## Terms of Agreement

**Fees Include:** All golf greens fees, room & board, meals, first aid attention (not including prescriptions, medicines, doctor/hospital visits, medical treatment, operations or procedures, x-rays, or anything that cannot be handled by our staff trainer). Multi-week sessions also include weekend trip fees.

**Cancellation/Refund Policy:** No refund of the deposit or tuition balance shall be permitted except in strict conformity with the following: Camper must notify US Golf Camps, in writing, at least two months prior to the start date of his/her camp session that he/she will be unable to attend for any reason. A full refund will be made of all fees previously paid less a non-refundable processing fee of \$450. Camper family agrees that no deductions are to be made from the tuition for a camper arriving late, leaving early, or missing any portion of the camp session. Also, no refunds are to be made for campers dismissed for disciplinary actions or misconduct. US Golf Camps reserves the right to dismiss, without refund, any camper whose influence is deemed detrimental to the camp.

**Payment:** A deposit of 50% is due upon registration. The balance is due by May 1<sup>st</sup>, 2008.

**Marketing:** I hereby consent to and authorize US Golf Camps the rights to publish, reproduce and use for advertising or any other purposes, any photograph, video image, audio recording or other likeness of my child.

**Medical Information:** All campers must have adequate medical insurance to cover all medical expenses incurred while at camp. US Golf Camps is hereby granted permission to secure any medical and/or surgical treatment and hospital service for my child.
